**MONTCLAIR BOARD OF EDUCATION DETERMINING TO  
RAISE MONEY FOR SCHOOL CAPITAL PROJECTS THROUGH  
THE ISSUANCE OF SCHOOL BONDS**

WHEREAS, The Board of Education of the Township of Montclair in the County of Essex, New Jersey (sometimes herein referred to as the “Montclair Board of Education”) has determined pursuant to N.J.S.A. 18A:22-18 that it is necessary to sell school bonds to raise money for the capital purposes and in the estimated amounts described in the Statement attached hereto; and

WHEREAS, the Montclair Board of Education intends to seek school facilities aid in the form of debt service aid and now requires funding for the projects to commence preliminary planning to develop the plans and specifications and the applications to the Department of Education for its approvals of the projects; and

WHEREAS, the Montclair Board of Education has determined to deliver the attached Statement to each member of the Board of School Estimate to request them to fix and determine the amount necessary for the projects as set forth therein and to certify such amount to this Board of Education and to the Township of Montclair pursuant to N.J.S.A. 18A:22-19;

WHEREAS, this Board of Education will prepare and deliver to each member of the Board of School Estimate an amended Statement once it receives the preliminary eligible cost and final eligible cost letters for the projects from the Department of Education; now therefore

**BE IT RESOLVED BY THE BOARD OF EDUCATION OF THE TOWNSHIP OF MONTCLAIR IN THE COUNTY OF ESSEX, NEW JERSEY, as follows:**

Section 1. This Board of Education hereby determines that it is necessary to sell school bonds to raise money in the amount of \$4,859,950 for the capital projects described in the Statement attached hereto;

Section 2. The Business Administrator is hereby directed to send a certified copy of the this resolution and the Statement attached hereto to each member of the Board of School Estimate and to request them to fix and determine the amount necessary for the projects as set forth therein and to certify such amount to this Board of Education and to the Township of Montclair pursuant to N.J.S.A. 18A:22-19;

Section 3. The Business Administrator is further authorized, together with other appropriate Board representatives under his direction, to make applications for project approval and a determination of eligible project costs and, upon receipt of the preliminary and final eligible cost letters from the Department of Education, to revise the Statement in accordance therewith, and to send the revised Statement to each member of the Board of School Estimate.

Section 4. This resolution shall take effect immediately.

**STATEMENT**

The Board of Education of the Township of Montclair in the County of Essex, New Jersey (sometimes herein referred to as the “Montclair Board of Education”) has determined and states pursuant to N.J.S.A. 18A:22-18 that it is necessary to sell school bonds in the amount of \$4,859,950 to raise money for the capital purposes and in the estimated amounts, including financing, work, materials and incidental costs, described below:

SCHOOL FACILITIES AID

This Board of Education has applied to the State Department of Education for approval of the Projects in accordance with the Educational Facilities Construction and Financing Act, N.J.S.A. 18A:7G-1 et seq. (the “School Facilities Act”) and the regulations promulgated thereunder, N.J.A.C. 6A:26-1.1 et seq. (the “Regulations”), and by letters dated \_\_\_\_\_, 2018, the Commissioner of Education has approved the Projects;

education, the board of school estimate shall present to the board of education, the governing body and the county superintendent a statement of the specific line-item reductions made by the board of school estimate, along with a certification that the board of school estimate has reviewed the budget proposed by the board of education and deems the revised budget sufficient for provision of a thorough and efficient system of education and that the reductions will not adversely affect the stability of the district given the need for long term planning and budgeting,

NOW THEREFORE BE IT RESOLVED that the Montclair Board of School Estimate, after careful study and due deliberation, has reviewed the 2018-2019 school district budget and decided to fund a Separate Proposal in the amount of \$50,000 for the purpose of Additional School Security at Special Events for the 2018-2019 school year thereby increasing the tax levy; and

NOW THEREFORE BE IT RESOLVED that the Montclair Board of School Estimate, after careful study and due deliberation, does hereby approve a Fiscal Year 2018-2019 school district tax levy in the amount of One Hundred and Fifteen Million, Nine Hundred Forty-One Thousand, Two Hundred Seventy-Nine Dollars (\$115,941,279) which is comprised of originally requested tax levy, \$115,891,279, plus the Separate Proposal, \$50,000; and

BE IT FURTHER RESOLVED, that the Board of School Estimate does hereby certify said amount to the governing body of the Township of Montclair pursuant to N.J.S.A. 18A:22-19, and

BE IT FINALLY RESOLVED, that the Secretary is hereby instructed to prepare two certificates of this action, one to be sent to the Board of Education of the Township of Montclair, and the other to the Council of the Township of Montclair.

WHEREAS, the Board of Education has submitted a request for capital funds for school purposes pursuant to NJSA Title 18A:22-18; and

WHEREAS, said purposes relate to raising funds for capital improvements, equipment replacements, play area shading, athletic field reconditioning, turf field replacement and district wide security as detailed on the attached list; and

WHEREAS, the Board of Education has estimated the cost thereof of Four Million, Seven Hundred Fourteen Thousand, Nine Hundred Seventy-Five Dollars (\$4,714,975), plus Section 20 costs of One Hundred Forty Four Thousand, Nine Hundred Seventy-Five Dollars (\$144,975) related to the issuance of bonds; and

WHEREAS, the projects requested meet the standards for capital projects pursuant to N.J.S.A. 18:A-21-1; and

WHEREAS, the projects are included in the district's Long-Range Facility Plan that was previously submitted to the New Jersey State Department of Education;

**WHEREAS,** the Board of Education of the Montclair Township Public School District has submitted a request for capital funds for school purposes pursuant to N.J.S.A. Title 18A:22-18; and

**WHEREAS,** said purposes relate to raising funds for the capital project involving the Montclair High School Stair Towers Replacement described in the Statement attached hereto;

**WHEREAS,** the Board of Education has estimated the cost thereof of One Million, Nine Hundred Eighty-One Thousand Dollars (\$1,981,000.00), plus Section 20 costs of Fifty Thousand Dollars (\$50,000.00) related to the issuance of bonds; and

**WHEREAS,** the projects requested meet the standards for capital projects pursuant to State law;
