WHEREAS, N.J.S.A. Title 18A:22-14 requires that the Board of School Estimate fix and determine by official action the amount of money necessary to be appropriated for the use of the public schools in the district for ensuing year, and

NOW THEREFORE BE IT RESOLVED, that the Montclair Board of School Estimate, after careful study and due deliberation, does hereby approve a Fiscal Year 2019-2020 school district tax levy in the amount of One Hundred Eighteen Million, Two Hundred Sixty Thousand, One Hundred Five Dollars (\$118,260,105); and

BE IT FURTHER RESOLVED, that the Board of School Estimate does hereby certify said amount to the governing body of the Township of Montclair pursuant to N.J.S.A. 18A:22-14; and

BE IT FINALLY RESOLVED, that the Secretary is hereby instructed to prepare two certificates of this action, one to be sent to the Board of Education of the Township of Montclair, and the other to the Council of the Township of Montclair.
